

FREEDOM HOUSE CONTRACT

This agreement is made and effective as of _____, 20____ by and between True Freedom Ministries located at 2182 Mitchell Road, Hartford, Alabama and _____ with a mailing address of _____.

WHEREAS the staff of Freedom House intends to guide the individual, known as the resident, to begin, and establish, a relationship with Jesus Christ as their Savior. The staff will be a role model for the resident and guide him in making this relationship the foundation of their entire life, so that everything flows from this.

IN CONSIDERATION of promises and other good and valuable considerations the resident agrees to the following:

- I. Resident's Duties:** The resident agrees they will act in accordance with this agreement and adhere to Freedom House's mission. The resident agrees to give their best efforts, time, attention, gifts, skills and all seriousness to begin a complete and radical change by the power of the Blood of Jesus; and to live their life based on His commandments and statutes, found in The Holy Bible.

- II. Resident's Responsibilities:** The resident agrees that he desires to and will put forth his best efforts in order to attain and maintain a life free from addiction, in every form. No drinking is allowed. No Smoking, Vaping, or Tobacco usage of any kind is allowed. No obscene or secular materials: literature or clothing. No cellular usage is allowed. Residents' phones will be taken at time of admission. The resident is not allowed to have contact with anyone for a minimum of two weeks after admission. The resident agrees to cooperate with Freedom House to learn how to live a life pleasing to God and to be fully restored spiritually, legally, and financially. The resident agrees to work to fully restore their relationship with family members. The resident agrees to live on Freedom House premises for six months and possess employment by the end of the six month period.

- III. Requirements of Resident:** The resident is required to immediately and permanently quit all substances and addictions, pay child support, write an apology letter to child/children, keep in contact with family and children in order to establish and maintain healthy relationships, pay fines, satisfy warrants and resolve all legal matters, obtain Drivers License (if needed, and resolve any issues concerning them) and learn the meaning and importance of tithing and put it into practice. The resident agrees to begin

outsourced labor, volunteering, and serving after admission where they are needed. The resident will be required to purchase and keep a Life Insurance Policy (with a minimum value of \$15,000) and complete a Personal Finance education course in managing money. The resident agrees to open savings and checking accounts. The resident agrees to behave in manners compliant to Freedom House's mission, objectives, and rules, at all times. The resident understands that a drug test can and will be given to him at any time, throughout their stay at Freedom House. The resident understands that all of his personal belongings may be searched at any time, without warning.
